DESCRIPTION AND BACKGROUND EXPLANATION

The aim of this recommendation for use is to specify the minimum requirements for a declaration regarding power supply.

Background:

TSI ENE 1301/2014 point 4.2.4 Traction power supply

TSI ENE 1301/2014 point 6.2.4.1a. Assessment of traction power supply performance

Description of the situation:

In accordance with point 6.2.4.1a the assessment shall be carried out by verifying only the existence of the declaration.

RFU PROPOSAL

In order to consider that a declaration according to TSI ENE 6.2.4.1a (1) is relevant to the project, the NoBo shall only accept a declaration about power supply if it at least contains the following content:

- Name and address of applicant.
- Name of the project.
- Name and signature of the applicant's representative.
- Date.
- Quality index according to Table 4 of the standard EN 50388-1.
- Infrastructure manager approval on the quality index presented by the applicant.

A statement that:

- The quality index of the subsystem complies with point 8.2 of the standard
